

Dear Detroit 600 Club Member,

The 600 Club Annual Tournament will be held at Cherry Hill Lanes, 300 N. Inkster Road, Dearborn Heights, Mi on Saturday, October 1, 2016 @ 1:00 pm.

1. All Bowlers must be certified in the Metro Detroit USBC and be able to produce their card/proof
2. You must use your highest yearbook average from the 2015-16 season with at least 21 games or a 21 game average from a 2016 summer league as of August 31, 2016 with acceptable proof from that league. If you haven't bowled since the 2013-14 season, you may use your highest yearbook back to and including that season. A current 2016-17 season of at least 12 games will be used with proof of average. If none of these apply you will bowl scratch, scratch average is 220.
3. The 10-pin rule does not apply.
4. All entries are placed on alleys by the order they are received. We shall do our best to accommodate groups if noted ahead of time.
5. Cash (no checks) entries will be accepted until 1 hour before tournament starting time.
6. Dues of \$3.00 are due October 3, 2015, this includes bowlers joining during 2015/16 season.
7. Failure to report highest average will result in disqualification if submitted average is lower than verified. Corrections will be allowed until the 10th frame of the first game. Prize winnings shall be based on verified average.
8. **NO REFUNDS** for the tournament, bowlers may send a substitute who is a member of the Detroit 600 Club. Previous tournament earnings need not be reported.
